No significant differences in IL-1RN and CD14-159 genotype or allelic frequencies were found among asthmatics, nonsmokers, or normal controls. Furthermore, no significant differences in CD14-159 allelic frequencies were seen between asthmatics and control subjects. Our results suggest that IL-1RN or CD14-159 polymorphisms are not major susceptibility factors for asthma in this group of asthmatic children. However, we cannot exclude the possibility of genetic linkage between a gene near CD14 and IL-1RN. within that theory." Id.
